



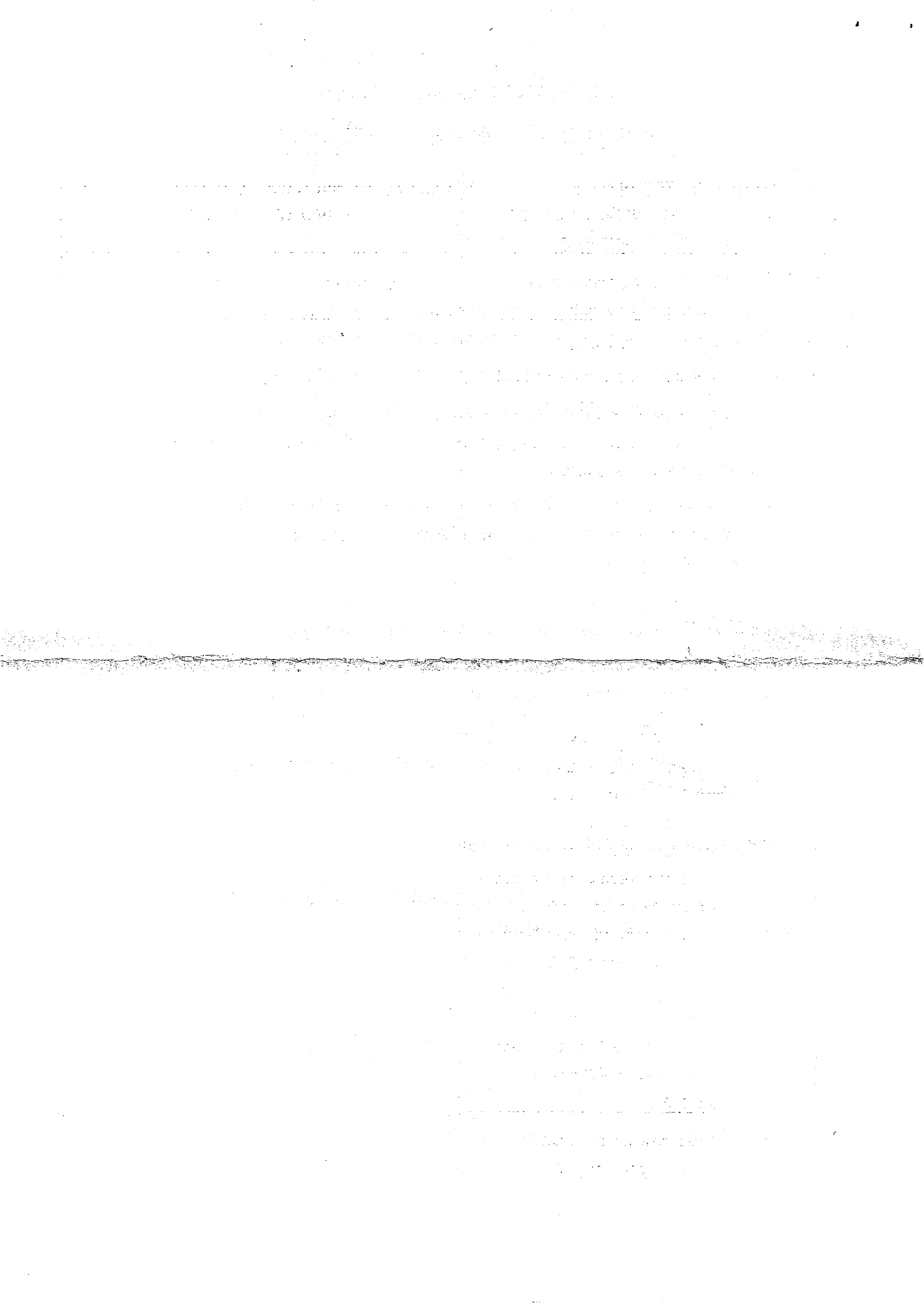

## **Explanatory Notes:**

<sup>1</sup> "Your partner" means (a) your spouse or civil partner; (b) a person with whom you are living as husband or wife; (c) with whom you are living as if you were civil partners.

<sup>2</sup> "12 months" means the period of 12 months ending with the day on which you give a notification for the purposes of the Localism Act 2011 ss 30(1) or 31(7).

<sup>3</sup> "Body" means a firm in which either of you is a partner or a body corporate of which either of you is a director or in the securities of which either of you has a beneficial interest. A director includes a member of the committee of management of an industrial and provident society.

<sup>4</sup> "Land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for you or your partner (alone or jointly with another) to occupy the land or to receive income.

<sup>5</sup> "Securities" means shares, debenture stock, loan stock, bond units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

### **Sensitive Information:**

Where you consider that the information relating to any of your interests is "Sensitive Information" and your authority's monitoring officer agrees you need not include that information when registering that interest, or as the case may be, a change to that interest.

"Sensitive Information" means information whose availability for inspection by the public could lead to you or a person connected with you being subject to violence or intimidation.

You must within 28 days of becoming aware of any change of circumstances which means that information excluded is no longer Sensitive Information notify your authority's monitoring officer asking that the information be included in your Register of Members' Interests.

### **General guidance:**

This form gives general guidance but is not comprehensive. The Council's Code of Conduct gives precise requirements. The Localism Act 2011 and the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 SI2012/1464 and any further regulations issued under the Localism Act should be referred to where necessary.
