Horsham District Council – Notification that BT are consulting HDC Planning authority which is a requirement when they intend to remove public payphone kiosks when they have had very little use over a significant period of time. It was suggested that it may be possible to convert the phone box into a public WiFi hub. Mrs Wright agreed to investigate the possibility of this suggestion.
