Youth Activities

In Mrs Towle's absence, she had requested that the funding of a Youth Club at the Allmond Centre be considered.

The cost for a member of staff from 4TheYouth to run the club would be £132.00 per week for 39 weeks totalling £5,148.00. The cost of the Allmond Centre would be in the region of £1,300.00 per annum. Mrs Towle suggested that to recover some of the costs, a weekly charge of £3.00 per child or £5 per family could be charged.

The previous Youth Club, also run by 4TheYouth was very popular with young people aged between 9 and 17 with attendance of 40-50 per week.

It was agreed in principle to the costs which would be formally voted on as an Agenda item at the September 2023 meeting.
